Poverty

Children Living in Poverty (<100% FPL)

Children birth through age 17 by their reported race or ethnicity (Hispanic or Latino) who live in families with incomes below 100 percent of the U.S. poverty threshold, as issued by the U.S. Census Bureau. This should be read as "3 in 10 Hispanic children live in poverty." The federal poverty definition consists of a series of thresholds based on family size and composition and is updated every year to account for inflation. In 2022, the poverty threshold for a family of four was \$29,678. The data are based on poverty status in the 12 months prior to the survey. Individuals who identify as Hispanic, Latino or Spanish may be of any race. Individuals who identify as American Indian and Alaska Native, Asian, Black or African American, Native Hawaiian and Other Pacific Islander, some other race, or two or more races may be of any ethnicity.

Poverty

Children birth through age 17 and young adults ages 18 through 24 who live in families with incomes below 100 percent of the U.S. poverty threshold, as issued by the U.S. Census Bureau. The federal poverty definition consists of a series of thresholds based on family size and composition and is updated every year to account for inflation. In 2022, the poverty threshold for a family of four with two related children was \$29,678. In 2023, this threshold increased to \$30,900. The data are based on the income received in the 12 months prior to the survey.

Low-Income

Children birth through age 17 and young adults ages 18 through 24 who live in families with incomes below 200 percent of the U.S. poverty threshold, as issued by the U.S. Census Bureau. The federal poverty definition consists of a series of thresholds based on family size and composition and is updated every year to account for inflation. In 2022, the 200 percent poverty threshold for a family of two adults and two children was \$59,356. In 2023, this threshold increased to \$61,800. The data are based on the income received in the 12 months prior to the survey.

Children Under 6 with All Caregivers in Labor Force

The estimated count of children under 6 years living in families and subfamilies where all available parents are in the civilian labor force divided by the total count of children under 6 years. The civilian labor force includes all people classified as employed or unemployed, excluding volunteers, institutionalized people and active duty members of the U.S. Armed Forces. A subfamily does not maintain its own household but lives in a household where the householder or the householder's spouse is a relative.

Median Income of Households with Children

The median annual income for families with their own children under age 18 through birth, marriage or adoption living in the household by family type. The median divides the income distribution into two equal parts: one-half of the cases falling below the median income and one-half above the median. Family income is the total of the incomes of all members related to the householder who are 15 years and older. Family type is defined as a married-couple family; male householder, no spouse present; and female householder, no spouse present.

Educational Attainment (25+)

The highest degree or the highest level of school completed for the population age 25 and older. Less than High School diploma includes people who did not complete schooling, dropped out between nursery school to 12th grade or did not receive a diploma. High school graduate or GED includes people whose highest degree was a high school diploma or its equivalent. Some college or Associate's includes people who attended college but did not receive a degree and people who received an associate's degree. Bachelor's or higher includes anyone who received a bachelor's, master's or professional school or doctorate degree.

Children in Households Receiving Public Assistance

The estimated count of children under 18 years living in family and non-family households with Supplemental Security Income (SSI), cash public assistance income, or Food Stamps/Supplemental Nutrition Assistance Program (SNAP) in the past 12 months divided by the total count of children under 18 years. Family households include a married-couple family; male householder, no spouse present; and female householder, no spouse present. A non-family household consists of one person living alone or with non-relatives only. Cash public assistance includes general assistance and Temporary Assistance to Needy Families (TANF).

Households with High Housing Cost Burden

The estimated count of occupied housing units with housing costs 30 percent or more of household income divided by the total number of occupied housing units. Occupied housing units include owner-occupied and renter-occupied. A housing unit includes a house, apartment, mobile home, a group of rooms or a single room that is occupied as separate living quarters.

Child Welfare

Disproportionality

This compares the number of Child Protective Services (CPS) reports, the number of substantiated CPS reports, and the number of valid General Protective Services (GPS) allegations by race and ethnicity to the census population from birth through age 17 for the same race and ethnicity categories. High disproportionality occurs when the CPS/GPS rate is greater than the proportion of that race group within the general population. Individuals who identify as Hispanic may be of any race.

CPS reports include reports of suspected sexual abuse, physical abuse, or serious neglect. Substantiations include indicated or founded incidents of child abuse that meet the definition of child abuse per the Pennsylvania Child Protective Services Law. GPS allegations include less severe reports of general neglect such as inadequate housing, parental substance abuse, truancy and parent-child conflict. These are considered valid when the report of general neglect included allegations that were found to have merit.

Early Care and Education

Children Enrolled in High-Quality, Publicly Funded Pre-K and Eligible Unserved

The number of 3- and 4-year-old children participating in high-quality, publicly funded pre-kindergarten programs. These programs include federal- and state-funded Head Start, school district pre-kindergarten, Child Care Works enrollments in Keystone STARS 3 and 4 facilities, Philadelphia pre-k (PHLpreK) in Keystone STARS 3 and 4 facilities, and Pre-K Counts. This number is subtracted from the census count of 3- and 4-year-olds living in families with incomes below 300 percent of the federal poverty level, as issued by the U.S. Census Bureau, to determine the total unserved.

Staff Needed to Serve All Eligible Pre-K Children

In Pennsylvania, pre-k programs must have a student:teacher ratio of no more than 20 students for one teacher and one teacher aide in a classroom (2 adults in a classroom for every 20 students).

Economically Disadvantaged Students

The percent of students identified as economically disadvantaged in the school district multiplied by the total district enrollment based on the October Student Snapshot, then divided by the grand total of relevant district enrollment. It is at the discretion of the school district to determine if a student is economically disadvantaged. Poverty data sources that may be used include Temporary Assistance for Needy Families (TANF) cases, census poor, Medicaid, children living in institutions that are neglected or delinquent, those supported in foster homes or free/reduced price lunch eligibility. This includes any school district with boundaries inside the county.

Proficiency
